Local Law Number 2 of 2018 Amending the Water Law

Be it enacted by the Village of
Stamford as follows:

§ 1 – Amendment to Increase Penalty Charge for Delinquent Fees.

Section 1 (“Payment for Water Service”), Subsection A of Local Law No. 1 of 1995 (as amended by subsequent local laws) is hereby amended to delete the last sentence of that section and to replace it with the following: “On bills remaining unpaid after 30 days, a 10% penalty charge will be added. If the bill remains unpaid after 60 days, a 15% penalty charge will be added”.

§ 2 – Amendment to Mandate the Property Owner is Billed for Water Service Section 1 (“Payment for Water Service”) of Local Law No. 1 of 1995 (as amended by subsequent local laws) is hereby amended to create a new subsection E, which provides as follows: “The Village shall bill the owner of the property for water service regardless of whether it is occupied by a tenant or some other person.”

§ 3 – Amendment to Clarify Fee for Suspending Water Service

Section 1 (“General Rules”), Subsection B of Local Law No. 1 of 1995 (as amended by subsequent local laws) is hereby amended to add the following sentence to the end of the subsection: “The Fee for suspending water service for nonpayment shall be incurred at the time the Village crew is dispatched to the property to suspend service”.

§ 4 - Severability.

If any provisions of this local law is held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the local law shall remain in effect.

§ 5 - Effective Date.

This local law shall take effect upon filing with the Secretary of State. Notwithstanding the foregoing, Section 2 of this local law requiring that property owners and not tenants be billed for water service to the property, shall take effect beginning on January 1, 2017.
